## 2013 CAMP MEETING WORKERS

When we think of spring and warmer weather coming to the north country, our thoughts turn to Richland Holiness Camp. What a privilege to have a scriptural Holiness camp meeting to attend! All camp meetings are struggling to survive in this electronic age, but with God's help, we'll continue Richland Holiness Camp Meeting until Jesus comes again. These things come about by prayer, fasting and giving; are you doing your part?

Growing up on a farm in Massillon, OH, Rev. Paul Kaufman attended Stoneboro Camp as a youth, early seeking God. He served in the U.S. Air Force during the Vietnam Era as a staff technologist in radiology. During that time he married Pearl, his wife of 45 years, and they have 2 daughters, as well as a new granddaughter. God's pathway for Rev. Kaufman has led to an interesting, active life. Early he learned the home building/carpentry trade; graduated from Salem Bible College in 1973, Baltimore Hebrew University (M.A. in Jewish Studies), Antietam Biblical Seminary (Doctorate), Lutheran Theological Seminary, Gettysburg (Masters in Sacred Theology), Kent State University (Ph.D. in American Religious History); pastored with the Allegheny Wesleyan Methodist Conf. 21 years; served as academic dean and professor at Allegheny Wesleyan College (wrote 3 accreditation self-studies for ABHE & the Ohio Board of Regents to enable the college to become fully accredited); served as a teaching fellow at Kent State U 4 years; served on a 3 member college accrediting team to a Bible college in San Juan, Puerto Rico, taught at Malone College, Canton, OH 21 years; taught at Ashland Theological Seminary, where he's now in his 25th year on the faculty; taught online classes for Indiana Wesleyan University for 12 years; has been honored with "Professor Emeritus" status at AWC, where he continues teaching part time; commutes by air to Florida to serve as chair of the Hobe Sound Bible College, Bible and Theology Dept.; takes evangelistic meetings; holds seminary lecture courses at Ashland, Detroit, Cleveland and Columbus; preaches regularly at the West Palm Beach Chinese Chapel; and has visited the Holy Land several times in recent years.

Rev. Stevan Manley, of Bedford, IN, graduated from Kansas City College and Bible School. He has served as a pastor 11 years, as a Christian school principal 5 years, as General Superintendent of the Wesleyan Holiness Assoc. of Churches 9 years, President of Evangelistic Faith Missions for 18 years, and entered the field of full time evangelism 6 months ago. Married to his wife, Helen, since 1969, they have one daughter and two sons, as well as ten grandchildren.

A board member of the camp, Rev. and Mrs. John Case return this year as our singers. Their ministry has led them to the Binghamton City Rescue Mission, pastoring for the Wesleyan Church and NY Pilgrim Holiness, 17 years in the Cayman Islands under the Wesleyan Ch. of the Caribbean Conf., and the field of evangelism. John and Betty have 4 surviving children, 13 grandchildren and 1 great-grandchild.

Rev. and Mrs. Ray Cope pastor the Petersburg, VA Allegheny Wesleyan Church, and will be coming to Richland as our Youth Evangelist. Ray and Kassia met and married while students at Allegheny Wesleyan College, where Ray graduated in 2009. They have 2 children, Raymond (5) and Allyson (2).

Richland Camp, one of the oldest Holiness Camps in the state, has always stood for the high standards of the true holiness people, and we have no desire or intention of lowering our standards. Our rules require "that all people" staying on the Camp Grounds are to comply with the rules of the camp.

## OUR CAMP STANDARD

- No cooking or fires of any kind allowed in the dormitories.
- No smoking on the grounds.
- Televisions and movies are not allowed on the grounds.
- Dogs and cats cannot be brought on the grounds or permitted to occupy trailers, tents, or cottages.
- Nothing is to be sold or distributed on the grounds except through the office or book store.
- Children are to be in the tabernacle or their cabin/room during services.
- Ladies, wearing of shorts, pants or mini-skirts by those rooming on the camp premises is prohibited. Men are requested to wear shirts and pants, and ladies to wear hose. The wearing of immodest apparel by either sex is strictly forbidden!
